Ms. Schauer directed Ms. Bursh to recognize that this meeting represents Dr. Yver's third consecutive absence for a regularly scheduled board meeting.

Since there wasn't a quorum, the board president called for a HRC Committee meeting to order at 5:21 p.m.

EXECUTIVE SESSION

The Board convened in Executive Session at 6:15 p.m.

WHEREAS, the Open Public Meetings Act, Chapter 231 of the Laws of 1975 provides that a public body may exclude the public from that portion of a meeting of which the public body discusses certain matters for which confidentiality is required as permitted in Section 7B of the act.

WHEREAS, the items that are permitted to be discussed in executive session are as follows:

SUPERINTENDENT'S REPORT/PRESENTATIONS

• Visual and Performing Arts Presentation: MHS Blue Moon Music Club

Ms. McLoughlin introduced Mr. Warshafsky, Supervisor of Visual and Performing Arts, who spoke about the MHS Blue Moon Music Club.

- Mr. Warshafsky thanked everyone for the opportunity to speak tonight in order to share the positives that are happening at this moment with the Blue Moon Club. He stated that this club is strictly student driven. High school senior, Mr. Harsh Grover, will discuss the club further.
- Mr. Grover reviewed the PowerPoint presentation he provided which shows how the club helps other communities in addition to Montgomery. The program will continue to expand. There is a club website which displays the services they provide. The club will also be discussed at freshman orientation in an attempt to draw more participants. There is currently a shortage in the number of tutors.
- The tutors, who are always high school students, use their own instruments. However, Montgomery students can borrow instruments if they don't own one.

• Ms. McLoughlin stated the district is preparing for the start of school and excited to have students back. There are some forms that are due by Friday. She reviewed various executive orders regarding masks and staff vaccination. Next week, there will be a virtual meeting with Dr. Mandelbaum and Ms. Stephanie Carey, Montgomery Township Health Officer. There will be three presentations in the next month.

NEW BUSINESS FROM BOARD/PUBLIC

- Member of the public, Belle Mead, asked what are the challenges that come with the hybrid version of instruction, especially if it needs to come back. Does the district have a plan to run school with hybrid instruction?
- Ms. Jennifer Dressler, Montgomery resident, advocated that parents have the choice on whether to mask their children or not at school. She stated that she does not believe we have received compelling evidence that masking children is safer for them. Secondly, she inquired if the teachers are receiving training to engage students with respect to shot status. She is concerned that this information may go into a database. Finally, Ms. Dressler stated she also concerned with the lack of parent engagement and board meetings. The board would like to see more engagement with the parents as well.
- Ms. Gabriella Zayova, Montgomery resident, would like to request that parents be given the option to opt out of masking their children. She would also like the board to provide evidence that masks make children safer and stated that she is concerned with the negative impact that masking children will have. If a child needs speech therapy or a behavioral therapy, who will pay for that?
- Ms. McLoughlin stated that regarding hybrid instruction, the district is prepared for contact tracing, which moved from six feet to three feet. If students need to quarantine, they will still be provided an education. There is no hybrid instruction as students will be masked and full in-person education. As of right now, the district is planning to open full-day live instruction but is ready for all other scenarios.
- Ms. McLoughlin replied to the next question, stating that the executive order mandates that students wear masks in school, which the district must abide by unless the student has a medical exemption.
- Ms. McLoughlin stated that the district will provide services for speech and behavioral therapies. In order to be medically exempt, a student must provide a letter from their doctor.
- Ms. Bursh stated it is alarming that students are questioned about their vaccination status by teachers. Ms. McLoughlin stated that our district does not question students on their immunization status. Ms. Spence-Wallace noted that N.J. Administrative Law 6A does not allow teachers or school nurses to discuss medical issues with the students.
- A member of the community from the audience stated she believes the unions are providing training to the teachers on how to ask about the vaccination status of students. MTEA President, Mr. James Dolan, stated that he knows nothing about this and would like to receive information regarding this issue because he wants to get to the bottom of it.

- Ms. Bursh stated she is also concerned with the amount of parental involvement at board meetings and would like to see that increase. The forum on September 1st will include a decision with medical personnel such as Dr. Mandelbaum and Ms. Stephanie Carey.
- Ms. Liz Rudamell, Skillman, stated that other districts and counties are making the decision not to abide by the mask mandate, why can't Montgomery?
- Correspondence to the board is acknowledged.

- MTEA Report Mr. James Dolan, MTEA President, reported that our School Leadership Team is busy at work processing on how to open school. Also, there was a District Leadership team meeting on August 19th in which we continued our work with equity. The district also held its new staff academy. Ms. Dolan thanked Ms. McLoughlin and Mr. Pappa for inviting Mr. Max Rodriguez, fourth grade teacher, to be included in the training. There will be continuing discussion on district goals and the new information coming out with COVID. The staff is working with the Governor's new orders on vaccines in addition to testing for staff members whom are unvaccinated. Ms. Staci Anderson, ESL teacher, is the new Pride Chair for the MTEA. In addition, the MTEA is giving out gift baskets to our first responders. Finally, in other good news, 905 books were given out over the summer to 106 students for the summer reading initiative so there's no summer slide.

Board Committee Reports

- <u>Assessment, Curriculum and Instruction Committee (ACI)</u> Ms. Spence-Wallace reported there was not a meeting scheduled for August. The next meeting is scheduled for September 28th.
- <u>Anti-Racism and Reform Committee (ARRC)</u> Ms. Bursh reported that the committee met last week and discussed the cultural audit. The committee is also planning to look at the code of conduct at the high school sometime in the future. They also discussed the structure of the committee and whether to keep it the same or change it.
- Operations, Facilities and Finance Committee (OFF) Ms. Bursh reported that the committee met on August 20th. A discussion took place about creating a water arrangement with the county at Skillman Park and the possibility of creating a rain garden at the water retention area at the Upper Middle School. The district has had success with the Seamless Summer Option free lunch and breakfast program which will continue into the fall. Parents may receive a note in Genesis on Friday asking if their children want breakfast. If the parent says no, there will not be a breakfast provided. Additionally, the district will be purchasing HEPA filters to help the students and staff breathe better. Finally, the committee is looking into being consistent with respect to the billing of groups who rent district facilities.

- <u>Policy and Communications Committee (PCC)</u> Ms. Specht reported that the committee did not meet. He will reach out to other committee members to schedule the next meeting and will be presented at the September 28th board meeting.
- <u>Human Resource Committee (HRC)</u> Ms. Franco Herman reported that the committee met in August. They discussed COVID protocols and other confidential personnel items.
- <u>President's Report</u> Ms. Bursh reported that the board has decided to table the board evaluation until the next meeting. The board's goals will also be discussed at the next board meeting. She attended the new staff academy and stated that it was a great experience. The board will also discuss the superintendent's merit goals at the next meeting.
