## **Conditions for Learning**

- General Health & Safety Guidelines (CDC)
- Classrooms- Social Distancing (SD) to best extent possible
- Transportation- Cleaning protocols, SD to best extent possible
- Student Entry/Exit/Flow SD or face coverings, markings on floor
- Screening/PPE/Response to Staff/Student presenting symptoms
- Contact Tracing-create protocols
- Facilities' Cleaning Practices-schedule routine cleanings
- Meals-Procedures for cafeteria/food service
- Recess/PE: Outdoor/Indoor spaces denote SD, no changing
- Extra-curricular/Outside school hours use of facilities: Protocols



## **Leadership & Planning**

- Scheduling- Must have in-person learning in some capacity
- Staffing- Clear expectations for student learning, expansion of roles to accommodate health & safety requirements
- Athletics- NJSIAA guidelines



# **Policy & Funding**

- Purchasing- PPE, Cleaning supplies
- Use of Reserve Accounts, Transfers and Cash Flowmust be mindful of areas in need of Commissioner's approval
- Costs and Contracting- Coops, E-Rate
- ESSER Funds- to support areas impacted by COVID
- FEMA- portion of eligible funds reimbursable
- State Aid- decline in funding



# **Continuity of Instruction**

- Special Education and Related Services- must follow students' IEPs to greatest extent possible
- Technology and Connectivity- access to device and to internet for all students
- Curriculum/Instruction/Assessments- deliver effective instruction in hybrid environment
- Professional Learning- Must provide staff necessary
  PD for instruction and safety protocols



## Restart and Recovery Plan Timeline

The Restart and Recovery Plan must be presented to the community 4 weeks prior to the first day of school for students. The plan must be reviewed by the Executive County Superintendent.

  - Continuous Forward Momentum
- Leveraging Synchronous In-Class Time
  - Increased Personalization
  - Increased Clarity
- Synchronous Instruction w/ Flexibility



#### Preliminary Thinking for Fall 2020

#### **New Digital Tools:**

- New Digital Learning Platforms
  - Phonics Practice, Science Simulations, Math Practice
- New PK-2 Learning Management System
  - On SeeSaw, students can complete learning activities, submit work in a variety of modalities, and receive feedback.
- Increased use of video platforms to create a blended school-home connection
