# **New Business/Announcements/Questions**

- OHES Back to School Night tomorrow presentations to go out to parents tomorrow afternoon
- Advisor from Interact Club has reached out to administration and are enthusiastic to help out

- Yuna has been in contact and we will be discussing how to get the word out at the next board meeting
- Mrs. Camuto has indicated that many parents would like a way to contact other parents and since we no longer make the friend finder it is problematic
  - Her children's school uses Membership Toolkit which allows you to find other members
  - The PTO uses this so Yuna will reach out to them
- Lara Katz would like to thank everyone for all the hard work they have done but point out that it is all very difficult for parents
  - Communication has been lacking and too last minute for parents to adequately plan
  - Bus routes were given Oct 9 for a start date of Oct 12 and children have not all been given Bus Tags yet - how does this short notice and lack of preparation ensure that our children are safe?
  - Transportation just said to check schedules weekly because can change but didn't say specific day - leaves a lot of room for error
    - Do we need to give transportation a deadline?
  - Schedules have been changing so hard to coordinate and some teachers have better practices than other, for instance a parent Q&A each week
- Administration's response:
  - Thank you for sharing your concerns
  - Hard to identify what we can control trying our best with internet connectivity and communication but things are changing so quickly
  - o Taking feedback from teachers about what is working well and what is not
  - Since only second week of hybrid still in the technology phase of troubleshooting
  - Don't want to take away teachers autonomy -things that work well for one class may not work well for another
  - Since families can choose to go virtual anytime the number of children on the bus can change at anytime so busing is fluid at the moment
    - Since parents have to go into Genesis everyday for the COVID questionnaire they can easily check the bus schedule

# **Q&A with BOE Member Ranjana Rao**

- True stakeholder involvement. Thank you for the invitation!
- Lots of chatter online, between parents how can we ease these concerns?
- Not all the questions were BOE questions so PTA has created a helpful chart to help determine which questions should be asked to whom (at end of document and linked to website)
- 1. Why do I have to fill out a form on Genesis DAILY when my child is virtual? There's no need for the school district to collect this information if my child is virtual. Why is this contingent for my child to participate over the internet?

- Kids may be participating in after school activities and may have younger siblings. This is for contact tracing as per the guidance of the Health Department
- If parents choose to go hybrid in Jan they will be already used to filling out the questionnaire daily
- 2. My son attends hybrid two days a week, but there are only 4 students including him in the classroom. What are the chances that he can attend 4 days a week and when would a decision like that be considered?
  - The distribution of children who are participating in hybrid program is not the same between schools
  - Many factors involved busing, different schedules at the upper schools, ensuring social distancing and cleaning protocols
  - There will be another survey in December to see how many may want hybrid in January and accordingly we can see if increasing the days for each cohort is possible
- 3. There have been cases of COVID diagnosed in nearby districts. What notification would go out to the classroom, campus and district in the event of a diagnosis? What is the expected timing of the notification?
  - Protocol is under 'Reopening' on district website
  - Flowchart explains exactly what will happen
  - Health department is immediately informed of a positive test, they will then tell the district
- 4. Communication has been challenging. Example: The decision to officially start/not start hybrid was supposed to be shared by the district at the end of September. Notification didn't happen until October 7. Where can parents go to get a status update on pending information even if said information is still being determined?
  - Communication has been challenging. Verbiage is governed so sounds very leagaleez
  - Were waiting on PPE until the very last minute so that is why communication was late
  - Don't rely on social media, only use primary sources teachers, BOE website
  - Trying to update BOE website so more user friendly
  - We can do better with information sharing and communications
  - Opportunities like this is a good way
- 5. Whether my child is in the hybrid model or fully virtual, how is the school district ensuring that my child's social/emotional self is being taken into account?
  - Lots of investment in teacher training to include SEL
    - Morning meetings repeating children's names so they feel included
  - Is a constant partnership with parents
  - The teacher/parent Q&A session once a month is a great idea
  - We are missing cues from children which we would normally see in a daily classroom
  - Work in progress and welcome suggestions
  - Teachers and principals are the best ones to contact if you have any concerns
  - Parent suggested Monty Moms is a good outlet for moms

- 6. The schools have continued to struggle with internet connection since Hybrid learning has begun. How has the district set up internet connections at the school? Are the networks set up to support the increased demands? Are in-person students and teachers all using Wi-Fi connections or is the internet hard-wired throughout the school? How can the connections be improved so that live instruction has less technical issues?
  - It is not a capacity issue but last week may have been a weather issue
  - It is a work in progress
  - If you have specific issues it should be brought to the school principal's attention
- 7. Why couldn't the district delegate fully virtual teachers for fully virtual students? Seeing kids in school while at home can be upsetting for some children.
  - Distribution of hybrid and virtual students is not static so it is hard to implement but it is something to think about in the future
- 8. Why isn't testing being required for teachers and students before entering "inperson" school?
  - Baseline testing is not mandated by the state so we cannot enforce it
  - Now that we know more about COVID spread we know that testing is not efficient unless doing it consistently
- 9. When will the children go back to school in person full time?
  - Don't know
  - We will follow the state and DOE guidelines and will keep everyone posted
  - Please see the reopening tab on the district's website for information
- 10. How can we focus on reducing screen time of students while staying remote?
  - We are all struggling since even non-school activities are also online
  - Could use more printable assignments as long as parents are ok with uploading the content so that the teachers can evaluate
- 11. Can new virtual kids do a quick tour of the school?
  - This would be something to bring up with the Principal and is not a board decision
  - Need to weigh the risks since we need to keep the pods tight
- 12. What is the teacher morale in general? What is the BOE doing to consider or improve their morale during this difficult time? How does the Montgomery faculty feel about hybrid learning in general? Are they for or against it?
  - Teachers are highly motivated and resilient
  - No way to substitute full-time in-person teaching but they are highly committed to educating our children in whatever model
  - District has invested a lot in professional development to help our teachers navigate
